AN ORDINANCE SUPERSEDING ORDINANCE 02-06

AN INCLUSION OF ORDINANCE 02-06 INTO CHAPTER 13 ARTICLE 3 SECTION 8 – SALE AND USAGE OF FIREWORKS.

Inclusion: Ordinance **02-06** into Chapter 13, Article 3, Sections 8, 9, and 10. It is necessary to address the overall sale and use of fireworks within the city limits of Krebs, Pittsburg County, Oklahoma.

Chapter 13 Article 3 Section 8 – The sale and usage of Fireworks.

- A. Prior to receiving a City License, the Vendor will need to show proof of a Sales Tax Permit or Exemption Permit provided by the State of Oklahoma for the collection of sales tax. The vendor will need to possess these forms and present evidence of ownership at the time the City license is sought.
- B. Sales of Fireworks from any vendor must be superseded with the purchase of a permit from the City of Krebs before progressing into sales. The permit can be purchased at the City Hall from the City Clerk or staff. The cost of the 30 day permit will be \$50.00 per stand.
- C. Only Class B fireworks can be sold. The sale or use of skyrockets with sticks, bottle rockets, cherry bombs, and M-80 are illegal.

Chapter 13 Article 3 Section 9 – Use of fireworks within the city limits.

- A. It is unlawful to ignite and/or explode fireworks within 300 feet of a church, public school, or where fireworks are stored or sold.
- B. Fireworks that are shot, burned, ignited, and generated trash must be picked up and properly disposed of.
- C. Fireworks shooter(s) are responsible for any personal injury or property damaged or destroyed.
- D. Only Class B fireworks can be used.
- E. In the event that a “Red Flag” alert is issued, a burn ban is put in place. All igniting/firing of fireworks is to be terminated.
- F. No guns are to be fired into the air nor any devised contraption that uses gun powder.

Chapter 13 Article 3 Section 10 – Time and Dates for legal uses of fireworks.

A. January – Class B fireworks ONLY between the hours of 11:30 p.m. on December 31st and 12:30 a.m. on January 1st.

B. Beginning the third (3rd) week in June through the second (2nd) week in July with the daily hours beginning at 10:00 a.m. and ending at 10:00 p.m. on Sunday through Thursday. On Friday and Saturdays the times will be 10:00 a.m. until 12:00 a.m. (midnight).

C. Special event permits may be allowed with the council's approval.
