## ORDINANCE NO. [ 24-02 ]

AN ORDINANCE CLOSING PLATTED ALLEYWAYS LOCATED IN BLOCK ONE HUNDRED FIFTY-ONE (151) IN THE NORTH AND WEST ADDITION TO THE CITY OF KREBS, PITTSBURG COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE RECORDED PLAT THEREOF.

WHEREAS, M & S Rental Properties, Inc. is the record owner of Lot One (1) through Lot Twenty-Eight (28), in Block One Hundred Fifty-One (151), in the NORTH AND WEST ADDITION to the City of Krebs, Pittsburg County, State of Oklahoma, according to the recorded plat thereof; and

WHEREAS, the City of Krebs shall retain the absolute right to reopen the public ways by ordinance without expense to the City of Krebs, unless the owner of the real estate to which any public way, or any part thereof, has heretofore reverted by closing, within the corporate limits of any municipality, shall commence an action in the district court in the county in which the real estate is situated, upon filing a verified petition, asking for the permanent foreclosure of the absolute right to reopen the public way, pursuant to Title 11 O.S. Sections 42-111, et seq.

NOW, THEREFORE, THE CITY OF KREBS HEREBY ORDAINS:

**Section 1.** That the City of Krebs deems it necessary and expedient to close to public use that portion of the public ways known as:

**Section 3.** Closing of the public way or easement shall not affect the right to maintain, repair, reconstruct, operate, or remove utility lines of service therein, nor shall a closing affect private way existing by operation of law unless released in writing executed by the owner thereof.

**Section 4.** That the City of Krebs deems it necessary and expedient to allow the perpetual non-exclusive use of the below described public way, for the purposes of constructing buildings, parking lots, driveways and similar facilities as necessary for the above-mentioned commercial retail project:

**Section 5.** The closure of the public way and the above-described use of the public way does not limit or restrict the City of Krebs from construction, laying, relaying, repairing, or operating any Town utilities that it deems necessary and prudent.

**Section 6.** This ordinance is duly considered at a regular public meeting of the City Council, and is approved and adopted by a vote of a majority of all of the members of the City Council. This ordinance shall become effective at the expiration of thirty (30) days after the adoption hereof, or at any other date specified herein.

**Section 7** Provision Cumulative: The provisions hereof shall be cumulative and in addition to any and all other provisions of the city ordinance

**Section 8**. Severability: The provisions of the ordinance are severable, and if any part of provision hereof shall be adjusted invalid by any court of competent jurisdiction, such adjudication shall not affect or impair any of the remaining parts or provisions hereof.

**Section 9.** EMERGENCY CLAUSE. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason of which this ordinance shall take effect and be in full force and effect from and after its passage, approval and publication.
