Mayor Walker until I see the paper work that y'all are making me do this, signed and everything then I will.

Dennis Cook, we don't issue paper work. We issue reports we have documentation we got all that stuff.

Mayor Walker, why can't I see it?

Dennis Cook, I turned it in. its in your monthly reports

Mayor Walker, I did not see anything about telling them to go tear a house down

Dan Heathcock we are talking about mowing the weeds and grass

Dennis Cook there were three abatements we did last month

Mayor Walker, show me something that says I have to make them go do that. That's up to y'all. You can hire somebody.

**David Bailey** didn't the council vote on it?

**Mayor Walker**, I got things for them guys to do. We got all kinds of problems going on. To go over there to mow a yard when we got water breaks, a dam to fix.

**David Bailey** I am not arguing the issue on that, I'm saying we voted to do it. Whether you have them go do it or not that's up to you mayor. I don't understand things anymore.

Mayor Walker you're the vice mayor while I was gone you should have had them go do it.

**David Bailey**, we had not even voted on it.
