1. MEETING CALLED TO ORDER by Mayor Bobby Watkins.
2. ROLL CALL called by W Kay Scott, City Treasurer. Bobby Watkins – present, Tommy Walker – present, Connie Poole – by phone, Jason Wagnon – absent, David Bailey – present.
3. PRAYER led by David Bailey. PLEDGE OF ALLEGIANCE led by Mayor Bobby Watkins.
4. DISCUSS AND ACT TO APPROVE THE MINUTES OF THE NOVEMBER 16, 2021 COUNCIL MEETING. Mayor Watkins asked for a motion to approve the minutes. David Bailey makes the motion to approve. Tommy Walker seconded the motion. Mayor Watkins calls for a vote. David Bailey – yes, Tommy Walker – yes, Connie Poole – yes. Motion passes.
5. DISCUSS AND ACT TO APPROVE THE CLAIMS. Mayor Watkins asked for a motion to approve the claims. Tommy Walker asked about a check for Mike Kern in the amount of \$11,045. Mrs. Scott stated that was a typo and the check needs to be voided. Will write a check for the correct amount of \$1,045.00. David Bailey makes a motion to approve the claims. Tommy Walker seconded the motion. Mayor Watkins calls for a vote. Connie Poole – yes, Tommy Walker – yes, David Bailey – yes. Motion passes.
6. REVIEW CITY OF KREBS FINANCIAL STATEMENT WITH MIKE KERN. Page 3 Statement of Revenues & Expenses – Month ending November Revenues = \$362,749.94. This has the ARPA monies that we just got in the amount of \$169,000. For the 5 months ending November 30 = \$1,122,294.10. On Page 5 – ended November with positive income of \$218,130.80 and 5 months ending \$93,336.76. We will transfer to KUA the ARPA funds which will show up in December. Any questions? None.
7. BUSINESS PREVIOUSLY DISCUSSED. None.
8. BUSINESS NOT PREVIOUSLY DISCUSSED.
 - A. DISCUSS AND ACT TO APPROVE A STIPEND OF \$162.43 LESS TAXES OF \$12.43 FOR A NET AMOUNT OF \$150.00. The mayor stated this is what we do every year for all the employees. Tommy Walker asked that this is \$150 total. There are employees that work in KUA & City. Mrs. Scott stated that there are 5 employees that are just paid out of KUA. This is for the city employees only. Mayor Watkins asked for a motion to approve the stipend. Connie Poole makes the motion to approve. Tommy Walker seconded the motion. Mayor Watkins calls for a vote. David Bailey – yes, Tommy Walker – yes, Connie Poole – yes. Motion passes.

- B. DISCUSS AND ACT TO APPROVE MEMBERSHIP TO THE WELLNESS CENTER FOR 2022 AT A COST OF \$1,500. POLICE AND FIREFIGHTERS WILL PAY \$15 PER MONTH. ANY OTHER CITY EMPLOYEES WOULD PAY \$25 PER MONTH. FAMILY MEMBERS WOULD BE AT A GRADUAL DECLINING RATE. Tommy Walker asked if the council members would be free. Mrs. Scott stated they would pay \$25 per month. David Bailey asked Police Chief Dennis Cook if any of the officers were using it. Chief Cook stated that he only knew of 1 that was using it. Chief Cook stated if he could make a suggestion, the Choctaw Nation has one on their property. It's \$10 for a lifetime for police officers and fire fighters. Mr. Bailey and Mr. Walker asked how many people use the Wellness Center. Mrs. Scott responded that she didn't know. She asked Jonathan Clifton where he went to workout. Mr. Clifton responded that he and Gary used Fassio's that used to be Dave's Fitness. Mr. Bailey stated that he didn't think it was worth it if no one was using it. Mayor Watkins asked for a motion. David Bailey made a motion to drop it. Tommy Walker seconded the motion. Mayor Watkins calls for a vote. David Bailey – yes, Tommy Walker – yes, Connie Poole – yes. Motion failed.
9. COMMENTS FROM THE COUNCIL AND MAYOR. Tommy Walker asked about burning. Mayor Watkins stated that it's still burn 11 a.m. – 2 p.m. Call in to McAlester. Mr. Walker stated that he has several people asking. David Bailey stated that there is a State Law that controls it. Mr. Walker stated that we can put something at the post office.
David Bailey asked about decorating at Christmas time better than what we do.
