1. Mayor Bobby Watkins calls the meeting to order.
2. Jessica Green, City Clerk calls roll. Bobby Watkins-present, Tommy Walker-absent, Connie Poole-present, Jason Wagnon-present. Daulfin Bennett-present.
3. PRAYER AND PLEDGE OF ALLEGIANCE
4. CONSIDER AND ACT TO APPROVE THE MINUTES OF THE DECEMBER 17, 2019 COUNCIL MEETING.
Mayor Watkins asks for a motion to approve the minutes. Connie Poole makes the motion to approve. Daulfin Bennett seconds the motion. Mayor Watkins calls for a vote. Daulfin Bennett-yes, Jason Wagnon-yes, Connie Poole-yes. Motion passes.
5. CONSIDER AND ACT TO APPROVE THE CLAIMS.
Mayor Watkins asks for a motion to approve the claims. Daulfin Bennet makes the motion to approve. Jason Wagnon seconds the motion. Mayor Watkins calls for a vote. Connie Poole-yes, Jason Wagnon-yes, Daulfin Bennett-yes. Motion passes.
6. REVIEW CITY OF KREBS FINANCIAL STATEMENT WITH MIKE KERN.
Nick Detello address the council. Nick states that we are half way through the year. Page 3, states that we need to watch the sales tax revenue. Nick states that we had a budget of \$600,000.00 and we are at \$324,000.00, also that we are ahead \$24,000.00. The City of Krebs took in \$145,000.00, and the total expenses were \$115,000.00. The Net income was \$31,000.00 for the month of December. Mayor Watkins asks the council if they have any questions for Nick.

- A. CONSIDER AND ACT TO APPROVE ESTIMATE OF \$6,100.00 BY J.D. THOMAS CONSTRUCTION FOR A ROOF, CONCRETE SIDE WALK, AND BLACK FENCE AROUND COAL.
Ed Klink address the council. Ed states that this is the largest piece of coal in the state of Oklahoma. Ed states the sidewalk and fence would improve the City of Krebs. Mayor Watkins asks for a motion to approve. Daulfin Bennett makes the motion to approve. Jason Wagnon seconds the motion. Mayor Watkins calls for a vote. Connie Poole-yes, Jason Wagnon-yes, Daulfin Bennett-yes. Motion passes.
- B. CONSIDER AND ACT ON THE PURCHASE OF GAS OR DIESEL GENERATOR FOR THE POLICE DEPARTMENT.
Chief Dennis Cook address the council. Dennis said having a generator would make the Police Department and emergency shelter if there was a disaster. Dennis would like to have gas generator, he states that it would be better than a diesel, if the power ever went out the gas would still be beneficial. Ed Klink stated that they did look into both. Connie Poole stated since this is Dennis department then he should be able to get what he wants. Mayor Watkins asks for a motion to approve for a gas generator. Connie Poole makes the motion. Daulfin Bennett seconds the motion. Mayor Watkins calls for a vote. Daulfin Bennett-yes, Jason Wagnon-yes, Connie Poole-yes. Motion passes.
- C. CONSIDER AND ACT TO APPROVE ORDINANCE 17-05 AMENDING ZONING CLASSIFICATION FOR TOWNSITE #7 LOTS 47, 48 & 49, AND A PORTION OF LOT 44. Approval for classification change was passed at October 17, 2017 Council Meeting.
Mayor Watkins states that this was approved already, during the process Tina Nelson's attorney passed away and never finished the paperwork. Mayor Watkins asks for a motion to approve. Connie Poole makes the motion. Jason Wagnon seconds the motion. Mayor Watkins calls for a vote. Daulfin Bennett-yes, Jason Wagnon-yes, Connie Poole-yes. Motion passes.
- D. CONSIDER AND ACT TO APPROVE EQUIPMENT AND BORING COSTS FOR FIBER OPTIC LINES TO CONNECT THE POLICE DEPARTMENT, FIRE DEPARTMENT, CITY HALL, AND THE SHOP BUILDINGS AT A COST OF \$8,886.92 THROUGH WAV11.
Kyle with WAV11 address the council. Kyle states that since the City is already going through upgrades, they are wanting to tie the lines together. He is wanting to boring them all underneath to protect them from damages. He stated they would be able to update the fiber to 10 gigs, that we will need. Mayor Watkins asks for a motion to approve. Connie Poole makes the motion. Daulfin Bennett seconds the motion. Mayor Watkins calls for a vote. Connie Poole- yes, Jason Wagnon-yes, Daulfin Bennett-yes. Motion passes.
- E. DISCUSS CHANGES TO 911 SYSTEM AND DISPATCHING.
Chief Chuck Nelms address the council. Chuck states that the Fire association is wanting them to sign a letter to form another 911 system. The County split from McAlester to have there own 911 system. Chuck states that if they do split then he feels that they would be going backwards. Chuck states that the money from Krebs 911 has always went to

McAlester, they are going to bill us if we stay. Chuck doesn't know if it is in our best interest to split, we are back up for McAlester Fire and they are the back up for Krebs Fire. He believes that the calls might get lost in the transfers with the new system. Dennis Cook states that he does not support that. Chuck stated that he will leave it up to the council if we sign the letter or not.
