1. Mayor Bobby Watkins called the meeting to order.
2. Jessica Green, City Clerk called roll. Bobby Watkins-present, Tommy Walker-absent, Connie Poole-present, Jason Wagnon-yes, Daulfin Bennett-present.
3. PRAYER AND PLEDGE OF ALLEGIANCE
4. CONSIDER AND ACT TO APPROVE THE MINUTES OF THE NOVEMBER 17, 2020 COUNCIL MEETING.
Mayor Watkins asks for a motion to approve the minutes. Connie Poole makes the motion to approve. Daulfin Bennett seconds the motion. Mayor Watkins asks for a vote. Connie Poole-yes, Daulfin Bennett-yes, Jason Wagnon-yes. Motion passed.

7. REVIEW CITY OF KREBS FINANCIAL STATEMENT WITH MIKE KERN.
Mike Kern addressed the council. Page 3 the revenue for the three-month ending November was \$259,112.71. The five months ending November was \$876,973.14. Mr. Kerns stated that the Cares Act we got was about \$117,000. On page 5 the total expenses for the five months ending were \$75,843.29. Mr. Kerns asks if there are any questions.

- A. CONSIDER AND ACT TO CONVERT THE MOBILE HOME PARK AT 120 SE MAIN TO AN RV PARK. TRACY PARROTT IS ASKING THE COUNCIL TO CONSIDER THIS PROPOSAL.
Mayor Watkins states that they are wanting to get rid of the mobile home park to put an RV Park in. Mayor Watkins asks to Table this until Mr. Parrott is available. DEADLINE AT THE PITTSBURG COUNTY ELECTION BOARD IS JANUARY 15, 2021 FOR THE 2021 REGULAR MUNICIPAL ELECTIONS. FILING PERIOD FOR THE ELECTION IS FEBRUARY 1, 2021 THROUGH FEBRUARY 3, 2021. THE NONPARTISAN MUNICIPAL GENERAL ELECTION WILL BE HELD ON APRIL 6, 2021.


10. COMMENTS FROM THE COUNCIL AND MAYOR


Connie Poole states that there will be a webinar about the COVID-19 vaccine.
