1. Mayor Bobby Watkins called the meeting to order.
2. Jessica Green, City Clerk called roll. Bobby Watkins-present, Tommy Walker-present, Connie Poole-present, Jason Wagnon-present, Daulfin Bennett-absent.
3. PRAYER AND PLEDGE OF ALLEGIANCE.
4. SWEAR IN DAVID BAILEY AS WARD 4 COUNCIL MEMBER.
Pat Layden, City Attorney swore David Bailey into office.
5. DISCUSS AND ACT TO APPROVE THE MINUTES OF THE MARCH 16, 2021 COUNCIL MEETING.
Mayor Watkins asks if there are any questions regarding the minutes. Mayor Watkins asks for a motion. Connie Poole makes the motion to approve the minutes. Tommy Walker seconds the motion. Mayor Watkins calls for a vote. David Bailey-yes, Jason Wagnon-yes, Connie Poole-yes, Tommy Walker-yes. Motion passed.
6. DISCUSS AND ACT TO APPROVE THE CLAIMS.

7. REVIEW CITY OF KREBS FINANCIAL STATEMENT WITH MIKE KERN.
Mr. Kern states on page 3 our revenue for the month of March was \$224,628.73. Mr. Kern states that the sales tax went up from the average. Mr. Kern states that our 9-month ending March 31, 2021 the total revenue was \$1,534,434.75. Mr. Kern states on page 5 our total expenses for the month of March 2021 were \$135,414.10. The net income was \$89,214.63. Total expenses for the 9-month ending were \$1,385,000.32. We have a net income of \$149,434.43. Mr. Kerns states that we will have a Finance committee meeting next month working on our budget for the next year. Tommy Walker states that everyone can come. Steve Defrange asks about on page 5 regarding the museum personnel being \$17,417.00 is that the year to date. Mr. Kern stated that he will have to look into it. Mayor Watkins asks if there are any questions.

NO APPLIANCES, PAINT, OR ELECTRONICS ALLOWED. TWO CITY EMPLOYEES PER DAY WOULD WORK OVERTIME ON SATURDAY AND SUNDAY. Mayor Watkins asks for a motion to approve. Tommy Walker makes the motion to approve. David Bailey seconds the motion. Mayor Watkins calls for a vote. David Bailey-yes, Jason Wagnon-yes, Connie Poole-yes, Tommy Walker-yes. Motion passes.
- B. DISCUSS AND ACT TO APPROVE ORDINANCE NO 21-02 EXTENDING THE MASK ORDINANCE TO JULY 19, 2021.

10. COMMENTS FROM THE COUNCIL AND MAYOR



David Bailey states that he's glad to be back and will do everything the best he can in his ward.


11. ADJOURN TO KUA.
