We had budgeted \$1,014,500 so we have revenues that were \$25,000 more. Expenses were \$955,273.36 and we have budgeted \$992,500 so we spent \$37,226.64 less so overall the profit is \$84,755.15. The other thing we need to look at is on page 7 the Statement of Cash Flows. Our Operating income was \$155,935.49. Our operating income needs to be in excess of 125% of the interest and principal debt payments which were \$82,800. Our operating income is in excess of the 125%. This puts emphasis on increasing the water and sewer rates. The Net Increase/Decrease in cash has a positive cash flow of \$61,527.16. At the end of the fiscal year, we have \$219,024.79. If we look at page 2, we still have to pay the City of Krebs \$214,299.31. We have to pay back our notes. We have to consider water and sewer rate increases to pay back these monies. Tommy Walker asked if we could put some of the money from the Customer Deposits money into a CD. Mr. Kern stated that amount of money is only one months' worth of expenses if needed. We can look at it at the Audit & Finance meeting.
