Repairs for the 6 months have been \$181,421.41 which has given a loss of \$70,145.77. We are on the positive side because of the monies transferred from the City side in the amount of \$244,852.30 for CARES monies and a regular transfer. On Page 2 of the General Ledger Total Repairs for sewer were \$123,185.04.
