Tommy Walker asks about the transfer from the last meeting. Kay Scott states that was from the Special Repairs and came out of the KUA. Mr. Kern asks if there are any questions.

A. CHERRI SPENCER TO DISCUSS THE WATER BILL AND SEWER ADJUSTMENT.

Cherri Spencer on behalf of Sammy Spencer addressed the board. Mrs. Spencer states that Sammy was in the hospital for 30 days, she stated she came home she found that the water was gushing down the driveway and found out there was a 2-inch water break. Mrs. Spencer stated that she hired plumber come in and fix the problem and spent \$800 to have it fixed and then paid \$200 towards the water bill.

David Bailey asks how much her average bill is? Mrs. Spencer said around \$200 and that is with the trash.

Connie Poole asks how much the usage was? Mrs. Spencer states it was 72,000, and the total bill was \$938.49.

David Bailey states that we should help the citizens. David states that it wasn't their fault they had a leak. Connie Poole states we should give her the average bill that she usually pays.

Chairman Watkins states that we will give her the regular water bill of the \$200.

Jessica Green, City Clerk stated that this was just a discussion not to act on this item.

Chairman Watkins asks Pat Layden if we can vote on this? Pat Layden states that we can vote on it.


8. COMMENTS FROM THE CHAIRMAN AND THE BOARD.
