- CONSIDER AND ACT TO APPROVE THE MINUTES OF THE MAY 19, 2020 KUA BOARD MEETING. Chairman Watkins asks for a motion to approve. Jason Wagnon makes the motion to approve.  - A. CONSIDER AND ACT TO APPROVE THE FISCAL YEAR 2020/2021 BUDGET.

- B. DISCUSS AND ACT CHARGING A FEE FOR CUSTOMERS THAT HAVE THERE POLYCART PICKED UP AND DELIVERED REPEATEDLY DUE TO NON-PAYMENT. Kay Scott, City Treasurer states that there are 30 customers that have trash only accounts. Out of those customers at least 7 of them do not pay their bill on time and we have to have their cart picked up and other issues that go on. She states that we can alleviate the problem if the council approves. Having the trash company not pick up their trash, charge a higher rate or charging an extra fee, raise the amount of the deposit. Daulfin Bennet asks about the fee. Kay Scott states that there is a fee of \$35 to stop service and restart their service. Connie Poole ask if they are any elderly people that are having problems. Kay Scott states that there is one that is having the issues but they have someone that takes care of their bills. She believes that the customers just forget to pay the bill every month. Pat Layden states that they need to have a motion on what they are approving. Kay Scott believes that charging them a fee would get their attention. Chairman Watkins asks for a motion to charge a fee of \$35. Connie Poole makes the motion to approve. Daulfin Bennett seconds the motion. Chairman Watkins calls for a vote. Connie Poole-yes, Daulfin Bennett-yes, Jason Wagnon-yes. Motion passes.
- C. CONSIDER AND ACT TO APPROVE THE ESTIMATE OF \$8,518.23 FROM GLOBAL ENERGY SOLUTIONS TO INSTALL NEW GATE VALVES AND CHECK VALVES FOR THE CLEAR WELL AT THE WATER PLANT.

Jonathan Clifton stated that Global Energy Solutions tried to install backup pumps, they ran into an issue regarding the valves. He stated that the only way to fix this is to drain the clear well around October so the usage is not high. This cost will replace other valves also. Chairman Watkins asks for a motion to approve.
