SECTION 3: Effective Date: This ordinance shall be effective on and after May 17, 2022.

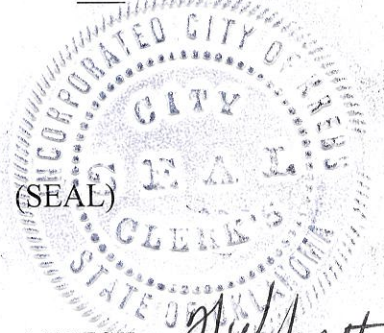
SECTION 4: Provision Cumulative: The provisions hereof shall be cumulative and in addition to any and all other provisions of the city ordinance.
