AN ORDINANCE FOR COMPENSATION OF THE MAYOR AND THE MEMBERS OF THE COUNCIL FOR THE CITY OF KREBS, COUNTY OF PITTSBURG, STATE OF OKLAHOMA

AN ORDINANCE ESTABLISHING SALARIES FOR THE MAYOR AND THE MEMBERS OF THE COUNCIL FOR THE CITY OF KREBS, OKLAHOMA; PROVIDING FOR INCREASES IN SUCH SALARIES; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MEMBERS OF THE COUNCIL OF THE CITY OF KREBS;

SECTION 1. The pay period for the Members of the Council of the City of Krebs shall be monthly. The members whose new term begins on or after April 2023, shall be paid each month the following salary during the performance of his/her duties.

ESTABLISHING A RATE OF:

Mayor	\$500.00 PER MONTH to be effective April 2023
Council Member Wards 1 & 3	\$250.00 PER MONTH to be effective April 2023
Council Member Wards 2 & 4	\$250.00 PER MONTH to be effective April 2025

SECTION 2. The effective date of this ordinance shall be August 19, 2022.

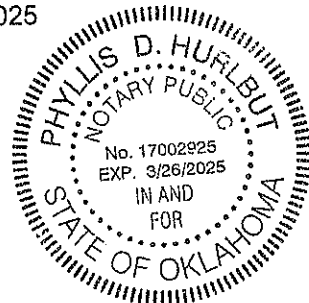
