A RESOLUTION APPROVING THE ACCEPTANCE OF FUNDS, A BUDGET AMENDMENT AUTHORIZING THE MODIFICATION OF AN INTER-LOCAL AGREEMENT WITH THE INDEPENDENT SCHOOL DISTRICT NO. 61-C009 (KREBS PUBLIC SCHOOLS) IN REGARD TO THE KREBS POLICE DEPARTMENT ACTING IN CONJUNCTION AS THE LAW ENFORCEMENT UNIT FOR THE SCHOOLS, AUTHORIZING THE AGREEMENT WITH THE INDEPENDENT SCHOOL DISTRICT NO. 61-C0096 (KREBS PUBLIC SCHOOL) IN REGARD TO THE KREBS POLICE DEPARTMENT PLACING A SCHOOL RESOURCE OFFICER WITHIN THE SCHOOL **AUTHORIZING** THE **SIGNATURE** OF ALL RELATED DISTRICT. AND DOCUMENTS.

WHEREAS, the City of Krebs has determined that it is in the best interest of its citizens to work cooperatively with Krebs Public Schools to place a School Resource Officer within the school district:

WHEREAS, the City of Krebs has determined that it is in the best interests of its citizens for the Chief of Police, School Resource Officer and other department employees to work with the district personnel as the School Districts Law Enforcement Unit;

WHEREAS, the School Resource Officer will be responsible for truancy, DHS child custody, delinquency issues, security at school events/functions; D.A.R.E., training for teachers (certified through the State), perimeter policing; sporting and extracurricular activities;

WHEREAS, the School Resource Office will work Monday thru Friday 7:30 a.m. to 4:30 p.m., and any other times as needed;

WHEREAS, the Krebs Public School will contribute \$20.73 an hour, which is approximately half of the cost of the School Resource Officer;

WHEREAS, acceptance of said funds by the Krebs City Council is required;

WHEREAS, a Budget Amendment is necessary to provide a project budget;

WHEREAS, approval of the documents associated with the agreements is in the best interest of the citizens of the City of Krebs;

## THEREFORE, BE IT RESOLVED by the City Council of the City of Krebs as follows:

- 1. The funds from the liquidation of surplus property are acknowledged and accepted by the City.
- 2. The following Supplemental Appropriation in the Police regular budget is approved:
